Notification

G.S.R..... (E). - In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Agriculture and Farmers Welfare, Department of Agriculture, Cooperation and Farmers Welfare, Farm Machinery Training and Testing Institute, Group 'A' and Group 'B' (Gazetted) Technical posts Recruitment (Amendment) Rules, 2015 , namely:-

1. (1) These rules may be called the Ministry of Agriculture and Farmers Welfare, Department of Agriculture, Cooperation and Farmers Welfare, Farm Machinery Training and Testing Institute, Group 'A' and Group 'B' (Gazetted) Technical posts Recruitment (Amendment) Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Ministry of Agriculture, Department of Agriculture and Cooperation, Farm Machinery Training and Testing Institute, Group 'A' and Group 'B' (Gazetted) Technical posts Recruitment Rules, 2015, – against serial number 3, relating to the post of Senior Instrumentation Engineer for the entries under column (11), the following entries shall be added, namely:-

Note 3 : provided that the eligibility service in respect of persons holding the feeder grade post i.e. Agricultural Engineer (Instrumentation) on regular basis on the date of notification of the revised rules, shall continue to be the same in the superceded rules.
