Sl. No.	Information Sought	Reply
1	I was relieved from North Eastern Region Farm Machinery Training and Testing Institute on 12-04-2012. At the time of issuing NOC the then Director Shri M.K. Vishwakarma was clearly mentioned in the letter that 'No lien will be maintained'. Kindly provide me the photocopy of the DOPT directives/ MO/ Order wherein it is mentioned that No lien will be maintained if any official seek NOC for applying any outside department.	Since, Shri M.K. Vishwakarma, Ex-Director was retired from Govt. Service on 31.01.2015, hence it is not feasible to provide his consent. The NOC had been provided by him at his own discretion.
2	Being a citizen of India, I have fundamental Right to know under which Rule/ Directives/ Office Memorandum referred/ emphasized by pay and accounts office and Ministry for disallowing the merger of pay scale (4500-7000) to (9300-34800) although it was approved by the Government. Kindly provide me the photocopy of the rule.	The copy of the letter vide which Ministry had turn down the pay fixation order and mentioned the reason of the same is enclosed herewith for your reference.
