NOTICE FOR INVITING EXPRESSION OF INTEREST

In order to popularize the use of Agricultural Drones among the farmers, the institute invites the 'Expression of Interest' for **Demonstration of use on "Use of Agricultural Drones for spraying application in the farmers' field"** from interested and eligible firms.

Scope of work:

- 1. Tentatively, the firm shall have to conduct minimum 5 (Five) demonstrations every month till 31.03.2023. However, this is subject to change at the discretion of the Institute.
- 2. Each demonstration shall cover at least 1 hectare of area with 1 (One) no. of Drone only.
- 3. The site of demonstration will be within the States of North Eastern region.

Terms and conditions:

- 1. The interested firms have to submit the **SEALED QUOTATION** addressed to THE DIRECTOR, NORTH EASTERN REGION FARM MACHINERY TRAINING & TESTING INSTITUTE, GOVT. OF INDIA, BISWANATH CHARIALI, DIST. BISWANATH, ASSAM-784176, so as to reach this Institute at **on or before 11th July, 2022 up to 5:30 pm**.
- 2. It shall be the sole responsibility of the firm to ensure that their pilot/co-pilot whom they depute for demonstration possess all the statutory requirements.
- 3. It shall be the responsibility of the bidder to ensure that it complies with all the rules / regulations applicable as on date.
- 4. The site as well as the date of demonstration shall be decided by the institute.
- 5. It shall be the responsibility of the firm to ensure that demonstration is successfully conducted on the scheduled date and site.
- 6. In order to ensure the uninterrupted demonstration, the firm shall maintain a set of adequate number of batteries which, in any case, should not be less than six. Power supply for battery charging will be provided by this Institute
- 7. In order to handle any major breakdown or other problems, the firm shall be equipped with standby equipments also.
- 8. The spraying material (insecticide, pesticide etc.) will be provided by the Institute.
- 9. Conveyance will be provided by the Institute from Institute to demonstration site. However, fooding & accommodation has to be arranged by the firm themselves. The demonstration team deputed by the firm should reach to this Institute on the proposed date at their own expenses.
- 10. The payment shall be made only after successful demonstration of agricultural drones for spraying application.
- 11. If the firm fails to conduct the programme as per the schedule, the work order awarded to him shall stand cancelled. Also the institute shall be free to take any official / legal action against the erring firm. The judicial jurisdiction will be at Biswanath
- 12. The bidder shall quote the rate on per hectare basis and shall remain valid up to 31.03.2023.
