

8.1.1 Rate of work:

a) The area covered was recorded as 0.1350 to 0.1598 ha/h at the average speed of operation from 2.70 to 2.85 kmph.

b) The time required to cover one hectare area was recorded as 6.25 to 7.40 h.

8.1.2 Quality of work:

- a) The depth of cut was recorded as 25.46 to 29.80 cm.
- b) Average working width was observed as 60.0 to 63.4 cm.
- c) Field efficiency was observed as 78.94 to 91.31 %.

Power requirement: 8.1.3

The average draft of implement was recorded from 913 to 1113 kgf and Drawbar power requirement was calculated as 200 cm. power requirement was calculated as 6.86 to 8.79 kW.

Labour requirement: 8.2

One skilled operator was needed to operate the tractor with the implement.

11. COMMENTS AND RECOMMENDATIONS

- 11.1 The dimensions of the share and share nose of plough does not conforms to IS: 10691-1983. This should be looked into for corrective action for standardisation.
- The dimension of hitch pyramid does not fully conform to IS: 4468–1997 (Part-1). Therefore, this should be looked into for corrective action.
- 11.3 The chemical composition in share was not within its range as per IS: 10691-1983. This is recommended to looked into for corrective action of standardisation.
- 11.4 The labelling plate should be provided as per the requirements of Indian Standard.

11.5 Technical literature :

Operator manual, service manual, parts manual covered in English was submitted along with the implements. However, it is recommended to bring out the same covered in Hindi and other vernacular languages as per IS: 8132-1999
