- 1. Though, the information sought by you through your application dated 25.09.2014 pertaining to 3 points were replied by our CPIO, Mr. Sanjay Kumar, Agricultural Engineer of this Institute in complete form, but, your application dated 20.10.2014 addressed to the Director says that, the <u>material information was not supplied by the CPIO</u>. In this context, please <u>clarify whether the information sought through</u> 20.10.2014 are separate information or the <u>supplementary information</u> for which you need not to pay the prescribed fee and reasons thereof.
