ORDER


In exercise of the powers conferred by Central Government vide Notification No. 186(E) dated 19th January, 2017 of the Ministry of Labour and Employment the undersigned hereby revise the rates of Variable Dearness Allowance for the workers employed in **Agriculture** w.e.f. 01.04.2017 on the basis of the average Consumer Price Index for Industrial workers reaching 277.5 from 271 as on 31.12.2016 (Base 2001-100) and thereby resulting in an increase of 6.5 points. The revised Variable Dearness Allowance as under would be payable from 01.04.2017:-

Therefore, the minimum rates of wages including the basic rates and Variable Dearness Allowance payable w.e.f. 01.04.2017 to the employees would be as under:-

The VDA has been rounded off to the next higher rupee as per the decision of the Minimum Wages Advisory board.
