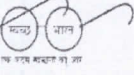



AUCTION NOTICE

Sealed tender are invited by the Institute for auctioning the "Farm Tea Produce" available in 4.08 hectare on a year basis. The interested bidders may submit their sealed tender to this Institute on or before 14.12.2023 up to **10.30 AM**.

Terms & Conditions:

- i. The auction is schedule to be held on 14.12.2023 in the committee hall of the Institute at 15.00.
- ii. The interested bidder may submit their tender in person or by post in the prescribed format to the Institute, by obtaining the tender from the Institute's website. The tender will be opened on 14.12.2023 at 15.00 in presence of the bidders.
- iii. The Tender form can be downloaded from the website of the Institute.
- iv. The maximum price will be accepted by the competent authority of the Institute.
- v. The auction is only for a year basis (i.e. 1st January-31st December, 2024) and the contract will be terminated immediately after completion of the contract mentioned above.
- vi. Any negotiation will be at the sole discretion of the competent authority.
- vii. The interested bidder may examine the tea garden prior to submit their tender with their proper identification.
- viii. The bidder will have to sign the order of acceptance with Institute for the terms & conditions stipulated, for safe guarding the government interest in all respect.
- ix. Successful bidder have to be submit **25% of the maximum price** at the spot and remaining payment within a week otherwise it will liable to be rejected and the deposit of the full amount.
- x. The transportation of produce and will be sole responsibility, arrangement of the bidder.
- xi. The labour engaged by the bidder must have proper identification; otherwise will not be allowed to enter in the office premises.
- xii. The engagement of child labour (Prohibition and Regulations) act, 1986 should be followed strictly.
- xiii. The security (bank guarantee; Demand draft, fixed deposit) 10% of the committee maximum auction price will need to be submitted by the bidder for in favour of Director, NERFMTTI, Biswanath Chariaal for safe guarding the government interest.
- xiv. The tea garden entirely is the property of government of India and any of the deficiency caused in crop (plants) by using the banned chemical / fertilizer during the contract period or harm to other Institute property except natural calamity; force majeure will be the sole responsibility of the bidder. The Institute will have right to charge full cost of the crop from the bidder in one sum.
- xv. For severe damages of plant the bidder will be held responsible and will be charged as per the government rules.
- xvi. Timely cutting & pruning, maintenance will be the responsibility of the bidder.
- xvii. In case of any dispute arises the judicial jurisdiction shall be Biswanath Chariali, Assam.
- xviii. The contractor (bidder) is bound to abide by all rules and regulations, disciplines and instructions issued by the Institute from time to time.
- xix. Any service tax on labours as fixed by the govt. of India in future will have to be borne by the bidder.
- xx. The competent authority reserves all rights to accept or reject any of the prices quoted by the bidder at any time without assigning any reason thereto.
