#### 11. COMMENTS AND RECOMMENDATIONS

- 11.1 The specifications of implement hitch do not conform to the IS: 4468 (Pt-I)-1997. Hence, it is recommended that implement should be provided with the hitch conforming to relevant Indian standards.
- 11.2 Dimensions of PIC of implement & PIC yoke bore of PTO drive shaft do not conform to IS: 4931-1995 and therefore should be looked into.
- 11.3 Suitable stickers indicating the grade & change period of oil used in gear boxes should be pasted on Rotavator.
- 11.4 Hardness and chemical composition of rotor blades do not conform to relevant Indian Standards. This needs to be looked into for corrective action.
- 11.5 It is recommended that arrangement for changing the rotor speed to suit various soils and moisture condition should be provided.
- 11.6 Make, size of implement and power requirement should also be indicated on the labeling plate.
- 11.7 Name of manufacturer is written as BABA FARM EQUIPMENTS on the application, whereas it is written as BABA FARM EQUIPMENT on the labeling plate, which is erroneous. Necessary correction needs to be done.
