8. EFFECTIVENESS OF SEALINGS

After completion of dry & wet land operation for 25.7and 17.4 hours respectively, the implement was dismantled for checking the effectiveness of sealing provided against ingress of dust, and water/mud in various sub-assemblies/components. The observations are given in ensuing table:

9. EASE OF OPERATION & ADJUSTMENTS

No noticeable difficulty was observed during the operation and adjustment of rotavator.

10. DEFECTS, BREAKDOWNS AND REPAIRS

No noticeable defect or breakdown was observed during 43.1 hours of field operation.

11. COMMENTS AND RECOMMENDATIONS

- 11.1 The specifications of implement hitch, does not conform to the IS:4468 (Part-1)-1997. Hence it is recommended that implement should be provided with the hitch conforming to relevant Indian Standards.
- Dimensions of PIC of implement, does not conform to IS:4931-1995 and therefore, it should be looked into for corrective action.
- 11.3 Hardness of rotor blades does not conform to relevant Indian Standards. This needs to be looked into for corrective action.
