10. DEFECTS, BREAKDOWNS AND REPAIRS

No noticeable defect or breakdown was observed during 40.3 hours of field operation.

11. COMMENTS AND RECOMMENDATIONS

- 11.1 The specifications of implement hitch, does not conform to the IS: 4468 (Part-1)-1997. Hence it is recommended that implement should be provided with the hitch conforming to relevant Indian Standards.
- 11.2 Dimensions of PIC of implement, does not conform to IS:4931-1995 and therefore, it should be looked into for corrective action.
- 11.3 Chemical composition of rotor blade does not conform to IS: 6690-2002. This needs to be looked into for corrective action in production level.
- 11.4 Size of implement and power requirement should also be indicated on the labeling plate.

11.5 **Technical literature:**

A booklet, named Instruction manual and Parts list was provided for reference during testing.

However, it is recommended to bring out the manuals also in Hindi and other vernacular languages as per IS: 8132-1999.
