### 1. SCOPE OF TEST

M/s Gobind Industries Pvt. Ltd., Village Dharsaniya, Lucknow Road, (Near Safedabad Railway Crossing), Barabanki – 225001, U.P. submitted Potato Planter for test. The Potato Planter was tested in accordance with IS 9856-1999.

The scope of test was limited to check and assess the following:

- 1.1 Specification and other data furnished by the applicant.
- 1.2 Field performance and suitability of machine for sowing potato seeds with regards to:
  - i) Metering mechanism to meter seeds at desired seed rate
  - ii) Quality of work
  - iii) Rate of work
  - iv) Fuel consumption
- 1.3 Ease of operation & adjustment
- 1.4 Hardness and chemical composition of critical components
- 1.5 Nature of breakdowns and repairs

#### 2. METHOD OF SELECTION

The test sample was directly submitted by the applicant, for test, at this Institute. Hence, Method of selection is not known.

## 11. COMMENTS & RECOMMENDATIONS

- **12.1** The dimensions of the three point linkage (Hitch pyramid) of the implement does not conform to IS:4468-2007. This should be incorporated at production level.
- **12.2** Material of bush does not conform to IS:11893-1997 and it should be looked into at further production level.
- **12.3** Row spacing does not conform to IS:11893-1997. This should be looked into and has to be incorporated at production level.
- **12.4** Instruction manual should be provided with the planter. It should also be provided with a manual containing maintenance, safety instruction and calibration chart.
- **12.5** As per IS:11893-1997 row maker and area recorder should be provided with the planter. This should be incorporated at production level.
- **12.6** In oil points hole should be provided for proper lubrication.
- **12.7** Hardened steel bolt & nut should be provided in the soil engaging parts to avoid frequent loosening from body.

### 12. ADEQUACY OF LITERATURE

Literature is not provided with the planter. A booklet containing figure of the machine, brief specifications, salient features, service & maintenance schedule, precautions and calibration chart should be provided for the guidance of the farmers and field personnel.
